## Parade Entry - Terms & Conditions

### **Mandatory Pre-Parade Float Viewing**

- A mandatory pre-parade float viewing will need to be held prior to the parade.
- The purpose of this meeting is to ensure the float is as described in the application, and safety standards are upheld. Any floats that arrive on parade day without prior approval will be refused entry.
- At least one member of your organization, and one Christmas in the Park committee member must be present.
- This will need to be scheduled at the time of receiving approval of your submission. In-person or Zoom meetings will be accepted.
- Organizations will receive final details, including final line-up, prior to the parade.

### **Participant Regulations, Terms and Conditions**

In submitting this application form, all parties understand and agree to the following participant regulations, terms and conditions.

### **Float Design**

- All floats must incorporate the Parade theme into their design.
- No Santa Clause, Mrs. Clause, or Grinch may be part of your entry.
- All entries must be family-friendly and entertaining.
- All floats carrying passengers are required to be constructed with safety railings around the perimeter of the float or all float passengers must be seated at all times.
- Limit 2 signs per float. All signs must be securely attached to float.
- Decorating the tow vehicle within the parade theme is highly encouraged

## Participant Regulations, Terms and Conditions (continued)

In submitting this application form, all parties understand and agree to the following participant regulations, term and conditions.

### Photo Consent

- We hereby grant the Christmas in the Park Committee and the Town of Devon the right and permission to use any and all pictures and film footage of your group/entry/float on social media, websites and news channels.

### Parade Notes

- Handouts, distributions and give-a-ways not allowed.
- There will be no premature exiting of the Parade route.
- Any entry may be refused entrance into the parade at any time, should the entry not meet parade guidelines or differ from its approved entry form.

### Health and Safety

- **Walkers** - Due to the parade length of 18km, walkers are discouraged.
- **Float Safety** - Float design must be safe to drive on the road, with all decorations and animations secured onto the float.
- **Participants** - No participants in the parade shall consume, nor give the impression of consuming, alcoholic beverages or smoking during the parade.
- **Insurance Coverage** – Organizations selected to enter their float must carry at least \$2 million in General Liability and will need to add the Town of Devon and Christmas in the Park as Additional Named Insured's to their policy. A copy of the insurance will need to be submitted to Christmas in the Park prior to November 19, 2021.
- **Waiver** - Organizations selected must sign a waiver on behalf of their group upon notification of selection.
